RESOLVED: that the proposed Financial Review Procedures as presented by Ways and Means be adopted. Motion passed unanimously.

RESOLVED, that the Executive Committee be empowered to act on the sale of diocesan property between regular meetings of the Board of Directors should it be necessary. Motion passed with one negative vote.

RESOLVED: that the Board of Directors of the Diocese of Iowa authorize funding for the training of two persons to be diocesan administrators of The Intercultural Development Inventory (IDI), a tool to assist organizations in understanding their cultural awareness and identify areas of strength or need for growth, in diversity, equity and inclusion. The administrators would be available to assist the diocese and congregations specifically when they are seeking to hire persons, or for any situation where having such an assessment will help our efforts to embrace

diversity, equity and inclusion in our life together; such as having the Board of Directors, or other organizations in the diocese, take the Inventory, and

RESOLVED further: the Board of Directors set aside funds totaling \$4,500.00 (\$3,000 from budget line 89, Program Development, and \$1,500 from Collaborative Ministry Reserve) for the training of two persons to start, with the possibility of a third should there be enough need. Motion passed unanimously.

RESOLVED: that the Board of Directors of the Episcopal Diocese of Iowa change its policy on building and land sale profits requiring a minimum of 50% of profits up to 100% be used for reparational work. The percentage or dollar amount will be determined by a sub-group of the board formed after the sale with input from former members of the church and community. Any remaining proceeds would continue to be moved to the New Mission Development Fund. Motion passed with one negative vote.

RESOLVED: that the Board of Directors approves of the policy Guidelines for Diversity, Equity and Inclusion (DEI) in the Hiring Practices for the Episcopal Diocese of Iowa. Motion passed unanimously.

RESOLVED, that the rectory St. John's, Keokuk, wishes to be sold be listed with an established realtor and that the listing agreement specify that sale is conditional on written approval from appropriate diocesan authority.

RESOLVED, that the Revolving Fund Loan application and request for interest rate at prime from St. Paul's, Grinnell, be approved.

COMMISSION ON JUSTICE, PEACE AND INTEGRITY OF CREATION

Chemical Dependency Committee Ms. Patti Christensen, Chair

Pathways to Serenity retreats are for those in the recovery community. This event has been growing again after the pandemic necessitated a 2 yr haitus of in person events. Lake Panorama is our usual meeting space and we've had transformational gatherings in Fall of 2022, Spring of 2023 and will have had another Fall gathering by the time this report is published. The need is great for healing and connecting like the kind experienced in these retreats that focus on several of the 12-steps each time. We are also collecting donations to help even those for whom the small fee is too much.

Faith in Action The Rev. Wendy Abrahamson, Episcopal Lobbyist to the Iowa General Assembly

Faith in Action (FIA) had a busy year. During the legislative session we were present for many subcommittee hearings, and for rallies at the statehouse to support the lgbtq+ community in the face of a number of anti- lgbtq+ bills, and over the session our lobbyist declared on 72 pieces of legislation. Thanks to the suggestion of the Rev. Stephen Benitz, FIA began a weekly gathering at the statehouse, Cassocks at the Capitol, where Episcopalians were encouraged to attend Interfaith Alliance's Moral Mondays offered at the statehouse over the lunch hour, followed by going to the rotunda to speak with legislators. Clerics were suggested to attend in black cassocks, which definitely elevated our visibility.

Cassocks were also worn for our 7th annual Episcopalians on the Hill event, including Bishop Monnot in a purple cassock. This was the first in-person gathering since the pandemic. A large number of attendees gathered to hear from legislators: Rep. Ross Willburn, Rep. Bob Kressig, and Sen Sarah Trone Garriott. Connie Ryan, from Interfaith Alliance also spoke with us. Then attendees had the opportunity to learn how to request a conversation with their legislator. We concluded with the required lunch at Tasty Tacos.

Over the course of a summer FIA represented the diocese by partnering in a statewide coalition, lowans for Responsible Gun Laws, that formed to try to stop the gun related Constitutional Amendment from passing. While the amendment did pass, the connection to other organizations was meaningful. The Rev. Abrahamson was a panel member about the amendment for Interfaith's Crossroads, as well as presented on the issue for a FIA Zoom gathering as well as at two congregations.

Significantly, there were two "brainstorming" sessions about FIA to consider ways the ministry might be shaped in the future. It first began in 2017, and it was a good time to pause and reflect. Attendees were The Rev. Deacon Jean Davis, The Rev. Lizzie Gillman, Iowa Senator (retired) Rob Hogg, The Rt. Rev. Betsey Monnot, The Rev. Michael Monnot, The Rev. Deacon Jeanie Smith, Bill Smith, Traci Ruhland Petty, The Rev. Cn. Meg Wagner, The Rev. Wendy Abrahamson, and a summary of reflections and suggestions were given to Bishop Monnot.

Currently FIA has a number of ministers: The Rev. Wendy Abrahamson, who coordinates FIA and serves as registered volunteer lobbyist for the Diocese; the Rev. Lizzie Gillman, who keeps FIA and the diocese informed of social justice issues; Vince Preston, and the Revs Diana Wright and Alice Haugen who serve as moderators for the FIA Facebook Group. The Rev. Canon Meg Wagner and Traci Petty both from diocesan staff give essential support, Meg by sharing justice issues and events, watching for and alerting the lobbyist about bills in the General Assembly; and Traci by making FIA accessible to the diocese through the diocesan web page, https://www.iowaepiscopal.org/advocacy, which is an excellent resource:. Additionally, many lowa Episcopalians make contributions to this ministry without which it could not be.

Finally, we have been grateful for the ministry and friendship of the Rev. Deacon Marcus Haack, who retired prior to the start of the session. Thank you, Marc!

MULTICULTURAL COMMISSION

Beloved Community Initiative The Rev. Nora Boerner, Interim Missioner for Beloved Community

Telling the Truth

The Reparations Task Force, which began meeting in 2021, concluded its work in 2022 and presented its findings at the 2022 diocesan convention. The task force proposed recommendations for further diocesan and congregational work in becoming a beloved community. These recommendations included preserving and documenting church histories with race, supporting diversity, equity, and inclusion in hiring practices, funding training for intercultural development facilitators, supporting healing gatherings for Indigenous communities, and dedicating a percentage of church asset sales to reparations. We are thrilled the diocesan Board of Directors approved all of the recommendations in June 2023.

In collaboration with the University of Iowa, we presented a screening and panel discussion of the documentary *JustUs*. This film shows the successful reintegration of former prisoners into society. Narrated and co-produced by a current inmate, the film is based in Des Moines, IA, and focuses on the experiences of Black Iowans. These individuals, who were formerly incarcerated, have not only managed their own rehabilitation but also positively contributed to society by supporting one another. These stories were told through interviews by local experts -- a prominent journalist, two state legislators, a lawyer, a group of social workers, a restorative justice leader, and other community organizers.

BCI continues to host monthly book groups with Showing Up for Racial Justice (SURJ), engaging in discussions and exploration. Since May 2022, the group has been reading and discussing *The 1619 Project* by Nikole Hannah-Jones.

There have been many other ongoing projects including the Diocese of Iowa History project, History of Race in Iowa Map, Virtual Library, Sacred Ground, Iowa Churchman periodicals, and Faithful Conversations about The 1619 Project. Hundreds of people participated in Beloved Community Initiative programs and worship in 2022 and 2023.

In July 2023, the Rev. Nora Boerner, the Rev. Cn. Meg Wagner, and the Rev. Kim Turner Baker presented at the Episcopal revival, "It's All About Love," in Baltimore, Maryland. The presentation was title, "Dismantling Racism in Predominantly White Space." As part of the presentation they were able to share the story of BCI and invite others to consider how to contextualize the work of Dismantling Racism in their ministry and communities.

Proclaiming the Dream

For the whole month of January 2023, BCI partnered with Gabriela Tobias from NangpaCommUnity to host a Meditation Marathon. Gabriela is a certified 200hrs Yoga Teacher and a student of the Budadharma Institute. This marathon involved 20-minute mindfulness sessions daily provided in both English and Spanish. These sessions provide space for participants to discuss their practice and ask questions, in addition to serving as an opportunity to bridge the mind and body.

JustChurch has been the worshiping community of BCI since spring of 2022. They meet for hybrid Holy Eucharist Saturday evenings at 5:00 pm. Worshipers join in-person at Trinity Iowa City and on Zoom from different counties and states and share in liturgical leadership. JustChurch lives out its mission to be a justice-centered community by being an 80/20 congregation. 80% of all offerings and donations go to justice-based work in Iowa and 20% goes to our operating budget.

Practicing the Way of Love

We've continued to host Dismantling Racism: Training for Church Leaders throughout 2022 and 2023. Five trainings have been hosted since August 2022. To date we've now trained over 400 leaders.

Sacred Ground is a film and readings-based dialogue series on race, grounded in faith. Small groups, or circles, are invited to walk through chapters of America's history of race and racism, while weaving in threads of family story, economic class, and political and regional identity. With the support of the working board of BCI, we offer Sacred Ground circles as often as we are able. In 2023 there were two circles on Zoom which allowed participants to join and learn together from a variety of locations.

Through JustChurch, BCI was present at the Trans Day of Visibility in Iowa City. We shared community, prayer, and Holy Eucharist with many people present.

Repairing the Breach

BCI actively engaged with community members through various events. We provided food, with the support of many Johnson County Interfaith Coalition (JCIC) partners, for a wellness event for teachers and staff of color in the ICCSD and surrounding districts. JustChurch and BCI were also invited to host one of the community meals in the summer at Wetherby Park. A number of Youth Serving Agencies (Neighborhood Centers of Johnson County, ICCSD, lowa City Parks and Rec, Dream City, CommUnity, and UAY) teamed up to better serve our young people through food, activities, and positive adult and peer interactions.

Acknowledging the intersection of reproductive healthcare and race, BCI responded to events in 2022 revolving around reproductive rights. Following the leaked Supreme Court opinion on Roe v. Wade in advance of the court case, BCI worked with local clergy to express their support for reproductive rights and protecting access to abortion. We gathered with community members, elected officials, and other local justice groups on The Pentacrest in Iowa City to express support for candidates in upcoming elections who were committed to supporting women's reproductive rights. BCI also worked with Interfaith Alliance of Iowa and local clergy to strategize how to maintain access for women and to offer resources on progressive theology that supports maintaining access to reproductive healthcare including abortion. Prior to the election on November 9, in 2022, Meg Wagner spoke at Pro-Rights Rally about the intersections of faith, racial justice, and reproductive rights on behalf of BCI.

BCI has continued to actively participate in JCIC via monthly meetings, but especially through the three initiatives from JCIC's Issues on the Wall: gun violence prevention, healthcare/mental health, and education. Listening sessions for each topic has been/will be held since February 2023. During these listening sessions, community members share their personal experiences and needs around these topics. Smaller committees have been formed to identify goals that JCIC will pursue in addition to local community initiatives.

BCI works with the court system and professional mediators and hosted multiple restorative justice circles in 2022 and 2023 that have successfully diverted people from felony charges and prison time and repaired relationships.

In June, 2023, a small group went on a journey to explore some sites of the Underground Railroad in SW lowa. This pilgrimage explored circumstances and issues associated with the Underground Railroad. Attendees visited three actual sites on the "Network to Freedom". While not an easy topic, one begins to appreciate the courage and commitment of the freedom seekers and abolitionists in lowa's early history.

The Wesley Center in Iowa City unexpectedly lost its office and gathering space in the spring of 2023. BCI was honored to be able to offer them space for the 2023-24 school year at Old Brick.

Future

Currently, BCI is awaiting the results of an expansive grant application from The Episcopal Church that, if granted, would allow us to hire a permanent Missioner and leader in 2024.

We hope that with this new leadership we are able to expand our work further across the state and re-build a community advisory board that is representative of many communities across lowa.

St. Paul's Indian Mission, Sioux City, Iowa The Rev. Dr. Marilyn van Duffelen, Bishop's Vicar

Greetings Brothers and Sisters in Christ,

I have served at St. Paul's Indian Mission since December 2016. During this time, we have received six grants from the Society for the Propagation of the Gospel to Natives and Other People, totaling \$24,700.00. With these grants, we have greatly improved the interior space of the building as detailed in previous convention reports. This year building maintenance work includes the exterior. Concrete repairs were made and the entire exterior of the building was repainted with a 10 year guaranteed exterior paint. We also replaced the refrigerator with two smaller ones and refinished the flooring in the parish hall. We also have funds to replace the fire door to the downstairs hall, which I hope to have completed shortly. In addition, the Santee Tribe has donated to St. Paul's ten new eight foot tables to upgrade our facility. They were delivered and set up by the Santee and are a very welcome upgrade to our hosting facility.

St. Paul's attends the Niobrara Convocation, held in June at one of the Sioux reservations in South Dakota. Members from St. Paul's and myself attend each year. In 2019, it was held in Yankton and two of our members were selected to be on the organizing committee. In 2020 and 2021 the Niobrara Convocation was not held and sadly, some elders on the organizing committee have passed away. In 2022 it was held in Sisseton, which is celebrating 200 years of Episcopal presence. In 2023 it was held in Lower Brule. St. Paul's members donated two quilts to be raffled to raise funds for youth ministry at St. Paul's.

We continue to provide free Wi-Fi and outside outlets for phone charging. We have also begun a new youth ministry of "Cooking from Scratch" where youth learn how to cook their favorite dishes from scratch, learning life skills and independence. It is very popular. We also held the church picnic once again. The temperatures were too hot for many to venture out and some were restricted by the reoccurrence of Covid, but it was good to gather again in this way.

We are thankful for the continued support of the diocese as we make our way forward in this changing world.

OLDER ADULT MINISTRY

The Rev. Stacey Gerhart and Mr. Bob Sessions

We had 13 participants from across the diocese in our Summer Ministry School & Retreat track on The Spirituality of Aging. This was the first time we have done a full-blown version of our seminar and we and the participants were pleased with the results.

Our workshop was pretty intense, requiring quite a bit of reading and journaling during the retreat, but we didn't hear or detect any difficulties with either activity. We had good participation from each member and interest didn't seem to falter.

As teachers we certainly learned a lot that we will use to shape our future workshops. We will be doing a 4-hour seminar at St. Timothy's in West Des Moines in mid-August, and we're discussing a possible autumn event at Christ Church in Cedar Rapids. We dearly hope that this topic will catch on across the diocese. As the populations in our society and denominations age, Mentoring/Sageing organizations, workshops and publications are catching on across the country.

COMMISSION ON ONE WORLD, ONE CHURCH (OWOC)

Meetings again this year have been held via Zoom. A hybrid in-person/Zoom meeting in August was planned but then changed due to health concerns.

In December 2014 the first Brechin-lowa-Swaziland Young Adult Pilgrimage was held in Swaziland. That Pilgrimage continued with a gathering in the Diocese of Brechin in July 2016. It was to be followed by a gathering in Iowa in 2020 but due primarily to Covid-19 it was delayed. Finally, in August 2023, a group of pilgrims and their Bishops met in Iowa. Amy Mellies and Traci Ruhland Petty from our diocesan staff updated their 2020 plans and hosted this event August 8-17, 2023. Iowa had two young adult pilgrims, Celia Powell and William Monnot. Storms on the east coast of the US changed incoming flights for both visiting delegations, and very hot weather also greeted them in Iowa, but all got an introduction to Iowa including a Meskwaki Powwow and the Iowa State Fair as well as the opportunity to meet with Iowa Episcopalians in Cedar Rapids and Des Moines.

The Workshop on Christian Unity met in Milwaukee this year under the leadership of The Rev. Chris Olkiewicz, pastor of Windsor Heights Lutheran Church, ecumenical officer for lowa's Southeastern Synod of the Evangelical Lutheran Church in America, and ex-officio member of OWOC. Our Ecumenical Officer, The Rev. Jean McCarthy, and Mike McCarthy both participated.

The Global Episcopal Mission Network (GEMN) Workshop met in Tampa, FL, in May with the theme of "Mission: Journey into Healing". OWOC members The Rev. Cn. Kathleen Milligan (Diocesan Global Mission Advocate) and The Rev. Ken Messer attended, as did Bishop Alan Scarfe (GEMN Board member).

International/Sustainable Development Mini-grants have been funded in our budget since 2001. The 2023 budget allocated 1% of budget income. Mini-grants were awarded as follows:

OWOC/Diocese of Nzara – Internet access for the Episcopal Diocese of Nzara: \$4,406.00 OWOC/Diocese of Swaziland – Food & Care at Neighborhood Care Points: \$3,000.00

Episcopal Church of the Good Shepherd, Webster City/Self Help International – Nutritional support for pregnant women and their children in the first 1,000 days of life in Ullo Traditional Area, Upper West, Ghana:

\$4,406.00 \$11,812.00

The Neighborhood Care Points in Eswatini continue to serve meals to community children. Since Bishop Ellinah's visit to our Convention in 2013 we have pledged \$20,000 per year for food distribution.

Education is a significant concern in both African dioceses. Iowans have supported travel to Kampala for university students from Nzara and also funding for St. Timothy's secondary school in Nzara. In Eswatini the Anglican Church runs two secondary schools and several elementary schools.

We wish to thank all of you who have contributed toward and participated in ministries in our Companion Dioceses. Lingering effects of the pandemic, decrease in food exports related to the war in Ukraine, displacement of people in South Sudan due to continuing political conflicts and the war in Sudan, and climate change plague the work done so there continue to be needs in both the Diocese of Nzara and the Diocese of Swaziland. It culminated, at least for those of us in the Three Rivers Chapter, in a great celebration of international unity set in motion on August 11 by endless tables of picnic food volunteered by local Episcopalians as a loving welcome for our companion travelers on the lawn of Christ Church, Cedar Rapids. In a

concluding dedication service led by all three bishops, a sapling Bur oak was planted on the lawn. Someday it will grow into a giant tree. May the same force bear fruit in the lives of each pilgrim!

By encouraging this and similar visits through the years, One World One Church has more than fulfilled its calling to spread God's love across the globe. May it continue to provide future food for the soul!

COMMISSION ON STEWARDSHIP AND PLANNED GIVING

Investment Committee

Mr. William H. Smith, Jr., Treasurer and Ms. Anne Wagner, Diocesan Comptroller

The primary responsibility of the Investment Committee is to review and evaluate the performance of investments of the Episcopal Corporation of the Diocese of Iowa and to advise the Board of Directors on these investments.

Our largest investment fund, the lowa Diocesan Foundation Fund, was established in 1959 and offers a convenient, professionally managed investment fund for the congregations of the Diocese of lowa, and some of the special purpose funds given to the Diocese. By creating a common pool of diocesan and congregational investable funds, participants are able to invest in a well-diversified portfolio. The Foundation Fund is managed by the Episcopal Church Foundation, in partnership with State Street Global Advisors.

The Episcopate Fund was established by the Sixth Bishop of Iowa and his wife, Gordon V and Florence K. Smith, and is intended to help underwrite the annual compensation package for the Bishop of Iowa. It provides for 65% of the bishop's compensation package. This fund is managed by RBC Wealth Management in West Des Moines, IA.

We have a socially responsible fund invested with the Sustainability Group. It invests in projects such as loans for low-income housing, and economic opportunity and development.

During 2022, we experienced a world-wide economic downturn with a loss of 13.7% of diocesan investments.

Ways and Means Committee Ms. Anne Wagner, Diocesan Comptroller

The Ways & Means Committee oversees the preparation, presentation and funding of the annual Diocesan budget; monitors current year income and expenditures, congregational pledges, parochial reports, and audits. They report to the Board of Directors.

Actions during 2022-2023:

- Received and reviewed regular pledge and budget reports and the status of congregational audits
- Continued work on a revision of the congregational audit procedures and checklist, and ways to improve compliance.
- Received the 2023 congregational pledges and Stewardship Share appeals
- Communicated with congregations on their appeals.
- Recommended a 2024 draft budget for discussion during the summer.
- Received comments about the 2024 budget and recommended a proposed 2024 budget to the Board of Directors for approval.

YOUNG ADULT MINISTRY

Ms. Traci Ruhland Petty & Ms. Amy Mellies

Fall/Spring Care Packages:

We continue to send care packages to young adults who have recently graduated from high school. Since 2021 when we started this, we have sent packages to over 40 young adults either at college, taking a gap year, or to those who went out into the workforce. The intention is to let young adults know that these transitions can be difficult but that no matter what, there is a community that knows they are there and cares for them. The boxes have silly items, necessities, and always treats to enjoy on their own or share.

Companions Pilgrimage - August 8-17:

The main focus of young adult ministry this year was hosting our Young Adult Companions Pilgrimage. The pilgrimage was comprised of young adults (18-35), along with diocesan coordinators and bishops from our three-way companionship of Swaziland (in Eswatini, Africa), Brechin (in Scotland, United Kingdom), and Iowa. All three bishops had been present and met at the Lambeth Conference in 2022, so the focus of the pilgrimage was on several of the "calls" from Lambeth: Anglican Identity, Mission & Evangelism, Creation Care, and Reconciliation. These calls formed the basis of the learning activities and discussion time. As the pilgrimage would mainly take place in the Cedar Rapids and Des Moines areas, both with major rivers running through them, and in keeping with the water theme of other diocesan events, the pilgrimage was called "Gather at the River."

The group was made up of 21 pilgrims total and were joined for a few days by The Episcopal Church's Africa Partnership Officer, the Rev. Daniel Karanja, and the Officer for Global Relationships and Networking, Jenny Grant. Iowa pilgrims gathered as originally planned on August 8th, but due to severe weather on the east coast our companions' flights were delayed and redirected, with no one able to arrive in Des Moines on the 8th. Plans were quickly adapted and on August 9th our coach bus took us to pick up Brechin pilgrims at the Minneapolis airport, and then drove to Cedar Rapids to pick up Eswatini pilgrims. Staying overnight at Prairiewoods Retreat Center in Hiawatha, the group spent the next few days exploring the Cedar Rapids and Iowa City area. We discussed and learned about ministry and reconciliation with Agape Cafe at Old Brick and the Beloved Community Initiative, and about environmental sustainability practices at Prairiewoods; we participated in a guided breathwork and meditation session with the Rev. Catherine Quehl-Engel; we picnicked, worshiped, and planted a tree as part of the Anglican Communion Forest Initiative at Christ Church, Cedar Rapids; and we had fun and got to know each other over shared meals, conversations, and mini-golf. When we left Hiawatha, we stopped at the Meskwaki Annual Powwow in Tama. Our Swazi companions wore their traditional clothing and we learned about and celebrated our different cultures.

We stayed the rest of the trip in a hotel in West Des Moines where we participated in a variety of activities and discussions. We learned about the underground railroad and racial justice at the Jordan House museum, environmental sustainability and creation care at the World Food Prize center, and how legislation and public policy affect all of these areas and more at our tour of the lowa State Capitol, hosted by State Senator Sarah Trone Garriott. For Sunday morning worship pilgrims joined St. Paul's Cathedral, Des Moines, where new cathedral canons - Bishops Dlamini (Eswatini) and Swift (Brechin)- were installed and the three bishops participated in a question-and-answer session following the service. To round out the trip with some "typical American" experiences (and fun!), we went to the mall, the lowa State Fair, an iCubs baseball game, an eatery & arcade/game park, and a diner. We concluded our time together by celebrating Holy Eucharist, and each pilgrim received a token to remind us of our time together, the relationships that we have built, the love that binds us together as one, and all that we have learned and experienced. We plan and hope to keep in touch with each other, and look forward to seeing what develops from these new relationships and experiences. Thank you to everyone who made this life-giving and life-changing pilgrimage possible.

YOUTH MINISTRY DEVELOPMENT TEAM (YMDT)

The Youth Ministry Development Team (YMDT) continues its work living into its mission to resource, serve, support, and minister to the children, youth, and adult leaders in our diocese. The team is comprised of youth and adults from across the diocese who are dedicated to the spiritual and personal growth of young people in the Episcopal Church. Our ministry is directed by our intentional goals:

 To bring the youth of this diocese together to build community and develop Christian leadership

- To help young people claim their places in the church at all levels
- To equip and train the adults who work with young people in our diocese.

We find our mission to be in keeping with the three areas of shared ministry from Bishop Monnot.

Over the past few years, the focus of YMDT has changed. We have held some purely fun events, tried a few new things, and felt the need to make sure all of the youth in the diocese know that they are welcome just as they are.

The following events were held over the last year:

- For the first time we offered a diocesan confirmation retreat. The retreat was held at the Christian Conference Center, Newton in September. We had three youth attend the retreat and two were confirmed at the opening eucharist at Diocesan Convention 2022.
- Diocesan Convention 2022: We had three youth (Lizzie Lyman, Sam Schirmer & Ernelia Abade) attend the 170th Annual Convention last October. Sam and Lizzie were our youth delegates and Ernelia (a foreign exchange student) was a visitor with the Schirmer family.

We also had several youth take part in the Youth Lock-in at St. Paul's during the annual convention. Youth took part in several outreach opportunities during the weekend. They put together personal care items for Connections Cafe at St. Paul's, they helped plant onions and garlic at the St. Timothy's Garden, installed a Little Free Library (put together and painted at EPIC) at Mills House and made a meal for the North Des Moines Community Fridge housed at St. Andrew's.

- Ski Trip: Our annual ski trip in 2023 was held as a one-day event at Seven Oaks in Boone and overnighted at St. John's, Ames. Participants enjoyed skiing, tubing and snowboarding. The youth had a great time on the slopes, played games at the Ames Community Center, and were fed well by Bruce Bjorklund at St. John's. Thank you to Rev. Tom Early and the people of St. John's for welcoming us into their space.
- Small Acts, Big Impact (SABI): This is a new event that was started in the spring of 2022 and we
 have continued. At this weekend event, youth participate in outreach ministries that local
 congregations are taking part in. In March we held a high school event at All Saints', Storm
 Lake where we packed Tornado Packs for the local school, worked on crafts with the youth at
 Hope Haven and assisted at TLC Canine Center in Newell, lowa.

In April we held a middle school event at Grace Church, Cedar Rapids. Youth helped pack food at the Coralville Food Pantry, sorted donations at the Grace medical lending closet, put together baskets for the Christ Church Swaziland fundraiser (raising over \$500), and made fleece blankets to hand out at Grace.

- Simpson Youth Academy: The Simpson Youth Academy is a unique program on campus that allows rising high school juniors and seniors to explore their faith and prepare for college. This year the diocese of lowa had two youth attend, Harold Freeman (St. John's, Ames) and Deric Tilton (All Saints', Storm Lake). Several Episcopalians from the metro area were invited to take part in the evening worship services that the youth put together. We look forward to the work these youth are doing in their communities and encourage all youth in the diocese to attend.
- EPIC Summer Camp: EPIC was held June 26-30 at the Christian Conference Center in Newton. Over 40 youth entering 4th-12th grade were in attendance. We were supported by six chaplains in addition to a number of counselors who split the duties of providing daily lessons based on scripture verses which the planning team had determined. This year's theme was "Jesus: The Person, The Myth, The Legend." Each day we had a different lesson: Monday-Jesus' Body, Tuesday-Jesus' Mental Health, Wednesday-the Joy & Grace of Jesus, Thursday-Jesus' example of loving and accepting all even when it hurts, and Friday-Jesus Christ as a Human. Each day we had time at the prayer tree, a wonderful lesson, games, crafts and lots of activities provided by the CCC staff. It was an amazing week of camp!
- Care packages were sent to all children and youth in the diocese whose contact information was sent to Amy. Over 150 packages were sent each month. The packages were centered on

different outreach ministries our congregations take part in. Youth learned about Project Linus, the food pantry at St. Andrew's, Des Moines, animal shelter donations that many congregations take part in during the month of October, the coat ministry that St. Mark's, Fort Dodge offers, Laundry Love at Trinity, Muscatine, and St. Andrew's, Chariton Chess Club. During Lent we offered a 40 Acts of Service Calendar. Youth were encouraged to choose acts of service they wanted to take part in, but YMDT offered many suggestions.

Looking ahead we are hoping to engage more youth in our events. We feel that now more than ever youth need to know they are loved and welcome in our congregations and at youth events. Our congregations should be safe spaces for youth to be who they are, especially now that school may not be a safe space and they might be outed to unsupportive family members if they share their true selves with friends and teachers. We are looking at bringing back Happening and New Beginnings but want to also offer alternative events for youth who those events do not connect with. We want to offer some mental health opportunities for youth and parents/guardians in the coming year as well.

This ministry is one that is not done alone. Many, many volunteers give up their time, energy and sleep to plan and execute these events. They are wonderful, caring people that I am so grateful to have in the diocese. Please keep our ministry, the youth of the diocese and their families in your prayers as we move along together on this journey that God has called us on.

Financial Reports of the Board of Directors:

IOWA DIOCESAN FOUNDATION FUND

Description

The lowa Diocesan Foundation Fund was established in 1959 and offers a convenient, professionally managed investment fund for the congregations of the Diocese of Iowa, and most of the special purpose funds given to the Diocese. By creating a common pool of investable funds, participants are able to invest in a well-diversified portfolio.

The Investment Policy of the Iowa Diocesan Foundation Fund establishes the investment policies and objectives of the Iowa Diocesan Foundation Fund to assist the Investment Committee and Board of Directors of the Episcopal Corporation of the Diocese of Iowa and the Investment Consultant in effectively supervising, monitoring and evaluating investments. That policy is available online at: http://iowaepiscopal.org/investmentpolicy.html.

State Street Global Advisors, as part of the Endowment Management Solutions Program of the Episcopal Church Foundation, was retained in 2015 for asset management of the Foundation Fund, at the direction of the Board of Directors of the Episcopal Corporation of the Diocese of Iowa. Trustee fees are based on the market value of all investments in the trust at the end of each quarter. During 2019, the Episcopal Church Foundation took over the tracking and reporting for all the individual organizations. Their reporting no longer uses participating units as a basis of determining the identity for each participating organization, but instead reports on market value for each account for every participating organization.

Valuation dates are fixed by the Diocese of Iowa as the last day of each month, and distributions are made to participating organizations on a quarterly basis. Participants may reinvest their earnings instead of receiving regular distributions. Trades may be issued or withdrawn on the first day of each month, provided that such request to make investment or withdrawal has been received by check or

in writing at the office of the Diocese of Iowa prior to the valuation date on which investment or withdrawal is to take place.

Performance Reports and Audited financial statements are available for review at the Diocesan Office.

Transitions

Active Transitions

- Trinity Cathedral, Davenport: The Rev. Christopher Potter is serving as interim dean through the Spring of 2024 as they search for their next dean, following the retirement of the Very Rev. John Horn on December 25, 2022.
- Trinity Church, Iowa City: The Rev. Lauren Lyon ended her service with Trinity on June 11, 2023. Trinity called the Rev. Jim Harrison to serve as interim rector for up to 2 years beginning September 1, 2023 while they search for their next rector. The vestry also decided to extend the Rev. Nora Boerner's letter of agreement and change her title to Assistant Rector from Curate.
- Christ Church, Cedar Rapids: The vestry called the Rev. Brian Gross to serve as Priest in Charge December 5, 2022 and in December, 2023 they will discern whether to extend the call to be rector or begin a new search process.
- St. John's by the Campus, Ames: The vestry called the Rev. Tom Early to serve as Priest in Charge on January 1, 2023 and in January, 2024 they will discern whether to extend the call to be rector or begin a new search process.
- Christ Church, Clinton: The vestry has published their profile and portfolio for a part time Priest in Charge and are accepting applications following the retirement of the Rev. Raisin Horn as rector on December 25, 2022.
- St. Matthew's by the Bridge, Iowa Falls: Members from the vestry are exploring the possibility of an agreement with Church of the Good Shepherd, Webster City and Grace Church, Boone to share clergy between them.
- St. Alban's, Spirit Lake and All Saints', Storm Lake: With the transitions of the Rev. Tom Early and the
 Rev. Stacey Gerhart, both churches are hoping to share one full-time priest and are creating a joint
 profile and portfolio.
- St. Paul's, Durant: The vestry is exploring a potential shared call with the local ELCA church and meeting for joint discernment in September, 2023.
- The Way Station, Spencer: The Rev. Beth Preston ended her ministry with The Way Station on March 1, 2023. The Core Team met together and with members of the diocesan staff to discern how and whether the ministry could continue and took a hiatus over the summer of 2023. The Board of Directors voted to close the ministry on September 9, 2023.

Completed Transitions

- St. Thomas', Algona: The vestry called the Rev. Kate Campbell as their part-time Priest in Charge in January 2023.
- Trinity, Waterloo: The vestry called the Rev. Abigail Livingood as their rector in August, 2023. A
 Celebration of New Ministry is scheduled for November 4, 2023 at 2:00pm.
- St. Paul's Cathedral, Des Moines: The chapter has decided to call the Rev. Nicola Dance as the 5th Dean of the Cathedral. Nicola had been serving as Acting Dean. The Installation and Celebration of New Ministry will be held Thursday, September 28, 2023 at 7:00pm.
- All Saints, Indianola: The Rev. Ben Webb ended his time with All Saints and the congregation decided to formally close. They held their last service on Easter Day, April 9, 2023.
- Trinity, Emmetsburg: The Rev. Beth Preston ended her time with Trinity on March 1, 2023. The congregation has decided to formally close and sell their building.

Lay and Clergy Leadership Development and Support

• Companions in Ministry: The goal of Companions in Ministry is to foster healthy and life-giving relationships among clergy in the diocese — both during and beyond critical periods of transition

in our ministries. The group is led by the Rev. Cn. Meg Wagner and the Rev. Kris Leaman and includes all newly ordained clergy and clergy serving new cures during the first two years of their ministry. The group meets in person and on Zoom, approximately 5 times each year to build an active learning community of colleagues focused on:

- o praying with and for each other and our congregations
- o sharing resources for addressing core challenges for congregations and clergy in times of transition and change
- o orienting new clergy to diocesan structures, ministries, and procedures
- o building relationships with our bishop and diocesan staff
- o sharing stories and experiences
- o tending to our own spiritual nourishment and self-care
- Mutual Ministry Reviews: All congregations are strongly encouraged to have annual mutual ministry reviews so that the clergy and leadership can regularly review the ministries of the church to effectively vision and plan for the coming year. The reviews can be done with an outside facilitator or be done internally. If you would like an outside facilitator, contact mwagner@iowaepiscopal.org. Mutual Ministry Reviews were facilitated with: St. Andrew's in Des Moines, Trinity Church in Waterloo, St. Paul's Episcopal Cathedral in Des Moines, St. Timothy's in West Des Moines, Christ Church in Cedar Rapids.
- Clergy Mentors: Working with Bishop Monnot, all newly ordained clergy have been assigned a clergy mentor.

Congregational Development

- Genesis II: Teams from six congregations across the Diocese of Iowa began meeting in February 2023 as the Genesis II Cohort. The congregations are: St. Thomas' Algona, St. Peter's Bettendorf, St. Paul's Cathedral Des Moines, St. Stephen's Newton, St. Martin's Perry, St. Timothy's, West Des Moines. The cohort meets two times per month for at least a year by Zoom with members of The Episcopal Church's staff on church planting and redevelopment to learn together, vision together, experiment boldly together, and deeply engage with their neighbors. The teams have explored things like negative bias and appreciative inquiry, neighborhood mapping, created congregational timelines, the chaordic path, 90-day strategies, and meeting their neighbors in the community.
- Area Mission Conversations with the ELCA: In 2023 conversations began with all three lowa Synods
 of the Evangelical Lutheran Church in America about possibilities to share clergy calls between our
 churches that need part-time clergy. Trinity Episcopal and St. Paul's Lutheran in Ottumwa formalized
 an agreement to share a half-time priest/pastor between them in August 2023. Area mission
 possibilities are also being explored in Durant and Fort Madison.
- Rural Shrink Smart Workshop: On August 12, 2023 the Diocese of Iowa hosted a group of faculty researchers from Iowa State University at St. John's by the Campus in Ames for a workshop focused on the quality of life in Iowa's small towns. The workshop built on five years of engagement by members of the team with a group of shrinking towns in Iowa where residents have been actively and positively working to protect, sustain, and even improve their quality of life even as they experience population loss. Participants were introduced to new resources to help people in small towns use public data and data visualization strategies to communicate with residents and inform community decisions. Research has found that people's perceptions of quality of life often correlate with the strength of their local relationships, what is called social capital within a community. We plan to have more conversations in the coming year about how our churches in small towns can actively contribute to positive quality of life in their own communities and ways to encourage others to join them in these efforts.

Chaplains to the Retired Clergy The Rt. Rev. Betsey Monnot

Bishop Monnot has invited a team to consider what shape this ministry could take in lowa — more to follow.

Clergy Spouse Network Organizing Committee The Rev. John Doherty, staff support

Bishop Monnot appointed people to this committee in 2023. Included persons are John Doherty as diocesan staff member, Mike Wagner, Susie Messer, Julie Gross, David Eddy and Doug Van Dam. We met several times developing a survey to be distributed which will address the desires for this group. The group feels it is important to gauge interest in this new group before we offer programs or gatherings. Look for this survey to come soon. The cleric in the family will receive notice first, so the spouse can have notice to watch for it and know it is not a spam email.

Commission on Church Property, Architecture and Allied Arts Ms. Anne Wagner, Comptroller

This Commission serves as an advisory group on questions of church property, financing, safety, building use by outside groups, and risk management of church property. They are also responsible for oversight of the Diocesan House, closed church properties, property, and liability insurance, and to review and approve Revolving Fund Loans applications that meet the criteria of the Revolving Fund Loan Policy.

During 2022 the Commission received a report on diocesan property and liability insurance. They consulted with St. George's in Le Mars and improvements made by the preschool renting space in their building, received information from St. John's Keokuk regarding their desire to sell their rectory, and closed on the sale of the church property in Waverly.

Commission on Ministry (COM) Mr. Kevin Sanders, Chair September 2022-September 2023

The Commission on Ministry advises and assists the bishop on matters of baptismal and ordained ministry in the diocese as described in the ministry canons of the national church. The commission met six times since the 170th diocesan convention: three times at the Diocesan Office and three times via Zoom. We conducted interviews at two in-person meetings, giving us the opportunity to try out (and refine) the changes that we worked on last year – improvements to our interview process and post-interview communication process.

In December, the commission recommended that the Diocese of Iowa apply to become a sponsoring diocese of the Bishop Kemper School for Ministry (BKSM) in Topeka, Kansas. The Board of Directors endorsed that application in January, and in early May BKSM notified us that our application had been accepted by their board. The COM has recommended BKSM as part of the formation path for some deacons and priests. Because of its proximity, lower cost, flexibility and comprehensive academic programs, it offers a welcome option to some persons preparing for ordination, particularly those aspiring to bi-vocational ministry. The commission is enthusiastic about the benefits that sponsorship provides us, including opportunities for shaping current and future programs at BKSM.

As part of our role supporting formation for ordained ministry in the diocese, the commission:

- Recommended Betsy McElroy for ordination to the priesthood
- Recommended Catherine Schroeder for ordination to the priesthood.
- Recommended one postulant for the priesthood for candidacy.
- Recommended one postulant for the diaconate for candidacy.
- Recommended two aspirants for the priesthood for postulancy.
- Recommended two aspirants for the diaconate for postulancy.
- Recommended one Ministry Development Team for postulancy.

• Continues to follow the progress of two postulants for the diaconate, two postulants for the priesthood, one candidate for the diaconate, and one candidate for priesthood.

Ministry Development Teams Mr. Kevin Sanders, COM Chair

Based on the proposition that God has gifted each congregation with all of the resources it needs to live out its calling in a specific local community, our Ministry Development Team (MDT) approach looks for leadership from within the congregation. Our Ministry Development Team Curriculum supports identified leadership teams in discerning the work to which God is calling the congregation and in equipping the team to lead the congregation in responding to that call.

MDTs now have a lengthy history in our diocese, and we have found the MDT concept to be a useful approach to engaging all members of a congregation in their call to ministry through baptism. A number of our congregations continue to flourish in ministry led by a Ministry Development Team. While no teams-in-formation are currently working with the Commission on Ministry (COM), there are teams in various congregations exploring the early phases of the MDT process. These teams are working through units of the lowa Ministry Development Curriculum but, as of this writing (August 2023), have not yet come before the COM for postulancy.

Over the past year, the COM has been working with Bishop Monnot to clarify our vision for Ministry Development Teams in our diocese, and to continue to improve the resources that we offer to MDTs in formation. That conversation is on-going. This is nothing new: it has always been a work in process. We encourage any congregation wishing to further engage its members in baptismal ministry to consider forming a Ministry Development Team. Community of Deacons The Ven. Judith Crossett, Archdeacon

The lowa Community of Deacons consists of 33 deacons: 18 active, 14 retired, two in formation, and one in process of transfer to lowa from Arizona. Of the retired deacons, 4 live out of state. All are invited to a monthly zoom meeting of the community. We also invite transitional deacons to join us for the time they spend as transitional deacons, as we (and the Commission on Ministry and Bishop Monnot) agree that it's important for priests to learn more about what deacons are.

Over this past year, we've done book discussion (Five Loaves, Two Fish, and Twelve Volunteers, Elizabeth Mae Magill), we've heard about the work and resources of the Fund for the Diaconate, we've become informed about the move toward deacon compensation and participation in the Church Pension Fund. We've also provided a deacon for (almost) every visitation Bishop Monnot has done over the last year and successfully asked for mileage reimbursement for deacons traveling from their home congregations to make these visits.

Deacon Pat Johnson and I co-led a Summer Ministries Retreat track, "What is a Deacon?" which was rewarding for us as well as the 5 participants. We had a surprise guest: retired Deacon John Harper visited the track Saturday afternoon, pushed us with further questions, listened, and contributed.

Our ongoing projects are to improve the diocesan website's information on deacons; to develop more mentors for deacons in formation and during the first two years of their service; to have us all be in compliance with requirements for SafeChurch and Anti-Racism trainings. We now have deacons on the Commission on Ministry and on the Diocesan Board of Directors; our prophetic voices, our experience and being as deacons have important voice and vote in these and all places in the church. What we value most in our meetings, however, is our time together.

Every month we check in: what's going on? What's a struggle? What needs praying for? It is exciting to be part of this sharing of our lives and to see deacons offering to help each other with the practical challenges of many of our projects, or simply with the geographical facts of being distant from our congregations and each other. We rejoice in our diaconate and diakonia; we are a community; we invite others to discern their call and join this community.

Leadership Council The Rt. Rev. Betsey Monnot

Bishop Monnot began meeting in conversation with a core Leadership Council team of the Standing Committee president, the vice president of the diocesan Board of Directors, and the Canon to the Ordinary. In time, this group expanded by invitation to include individuals representing various demographic groups within the diocese, to participate in developing strategic planning discernment.

Professional Development Leave The Rt. Rev. Betsey Monnot

Professional Development Leaves are for the purpose of encouraging professional growth and an increased competence of the clergy and lay professionals, which will contribute to the life and work of the Church in the Diocese of Iowa. Leaves may be granted for regular study at any academic level in a college, university or seminary, for research in a specific area of the Church's life, or for other creative work, which will benefit the Church in the Diocese of Iowa.

One cleric (Nicola Bowler) received a Clergy Continuing Education grant in 2022.

Small Church Report The Rev. John Doherty

Leadership from several small churches (25 ASA or less) gather on Zoom every Monday. Some are ordained ministers others are lay members. Some have Ministry Development Team history. We provide mutual support and ideas as we discuss the many aspects of our church lives. We share both blessings and concerns. A small church core team was formed which in turn formed task groups. One is reviewing how small churches are affected by the policies and Constitution & Canons of the church. Another group is looking at small church ministry in other dioceses. These groups grew out of several years of work by small church leadership to call attention to the uniqueness of a small or tiny church's situation and to the many lessons they can share with churches of a larger size. We encourage others to join us. Many of us are participating in Province VI small church group discussions which began in September 2022. We are sponsoring 'Pathways along Loneliness & Solitude', on October 28, November 11, 25, and December 9th. We hope you will join us and invite others. Diocesan Officers:

Chancellor Mr. William Graham

The chancellor has consulted with the Bishop, the Bishop's staff and other individuals on matters of legal significance, as appropriate, and has assisted with legal matters, as necessary.

Historiographer Dr. Hal Chase

Dr. Hal Chase, was elected Historiographer of the Diocese of Iowa at last year's Convention and has been visiting congregations all over Iowa since last November when Bishop Monnot requested he lead an effort to create a chapter on Bishop Scarfe's term as Bishop of Iowa to bring the history of our Diocese current. Agape Café - Iowa City Ms. Jenny Britton, Co-Director and The Ven. Judith Crossett, Member of Bishop's Advisory Committee on Agape Café

Agape Café is celebrating 30 years of providing good food served with kindness: a hot, cooked-to-order breakfast to anyone who comes. The Café has recovered from the pandemic closure to serve as many guests as ever each week. We are now serving year-round, every Wednesday morning at Old Brick in lowa City, so our total number of meals served has increased. We now offer each guest a "to-go" meal in addition to ordering their choice for a hot meal to eat in the community of the Café, and we usually have additional food (sandwiches, fruit, etc) available for our guests to take.

Under the supervision of faculty from the College of Nursing, nursing students both help as servers and staff an outreach table to provide appropriate medical screenings and services; a foot and wound clinic in November, 2022, was particularly well-received. We are exploring a partnership with the University of Iowa Mobile Clinic to offer expanded screenings at the Fall 2023 Foot and Wound Clinic.

Hiring Joe Klingelhutz, to share the co-director position with Jenny Britton, has made the expansion to year-round possible, and has allowed the Café to pursue grants more than in past. We are also investigating becoming a partner agency with the Johnson and Washington County United Way. Grants from local faith communities, the Department of Natural Resources, the Farm Credit Services Bureau and other sources have provided improved coffee service, freezers for storage (especially useful if we get a 'deal' on foods we can freeze in bulk), bookkeeping software and help with bookkeeping and formalizing a budget. Food costs have increased; our fundraising and partnerships with many agencies are essential to providing good food served with kindness to our guests.

The Café continues to operate with dedicated volunteers; we recruit new volunteers each year and also say goodbye to some. This year, Mary Lynn Eckert, who has been with the Café since its founding, is retiring from the Advisory Committee and her role as Treasurer. Bob Sessions, a member of New Song Episcopal Church, has joined the Café Committee.

Old Brick Board of Directors The Ven. Judith Crossett, Liaison to Old Brick Board

The Old Brick Board has dealt with major maintenance issues this year while the use of Old Brick has continued to recover from the pandemic shut down. Groups have come back to meeting in the building (the ballroom dance group from UI, for example); most offices are occupied. Overall, operations are in the black year-to-date.

Major maintenance has included successful repair to roof and gutters, repainting the major space, and replacing a major air-conditioning unit. The boiler will also need repairs, but after consultation with the contractor, we agreed to defer the boiler work to spring of 2024. Carpeting has been replaced as tenants leave.

Several Board members and director Julie Thomas met with the Brechin-Swaziland-Iowa Pilgrimage group in August. The work of Agape Café and Beloved Community Initiative were presented and a tour of the building offered.

The Way Station – Spencer, Iowa The Rev. Cn. Meg Wagner and Ms. Anne Wagner

The Rev. Beth Preston retired from The Way Station on March 1, 2023. Beginning in late 2022, the Bishop, Cn. Meg Wagner, and Anne Wagner began meeting with Beth and the Core Team to discern if they would have the leadership capacity or funding to continue after Beth retired, and there was clearly a desire for the ministry to continue. There was also a lot of appreciation for the things that The Way Station had accomplished, who it had reached and connected with in the community, and for Beth's leadership.

The Core Team had functioned as enthusiastic and faithful volunteers, and a good sounding board for Beth as the ministry was built. In her absence, it was clear that more would be needed from each of them in order to keep the ministry going. Becky Prentice agreed to chair the team and be the liaison with the diocese. Carla Jans, who had served as Beth's assistant, increased her hours to 25 per week. The team discussed what they could and couldn't commit to going forward.

Carla decided to give her notice at the end of May and Meg conducted an exit interview with her on June 7. Over the course of 2 more meetings with Bishop Monnot, Meg and Anne, the seven Way Station board members voted to close the doors for the summer months and discern if they had the energy and will to continue the ministry and to explore potential partners for the ministry. Becky Prentice agreed to regularly continue caring for the building and property.

While taking the summer off from ministry, the Core Team of The Way Station met individually with Becky and determined that while they valued the ministry and the good work that had been done, they were clear they did not have the time and energy for continuing.

The Diocesan Board of Directors voted officially to end the ministry on September 9th and directed the property commission to begin the necessary work to sell the building and assets.

Diocesan Coordinators/Resources:

Altar Guild Ms. Stephanie Wells, Director

Diocesan services supported by the diocesan Altar Guild over the course of this past year have included Chrism mass (with prepared oils and a lunch following) and ordinations held at St Paul's Cathedral. Also: cleaning and maintenance of supplies and linens for the Chapel located in the Bishop's Office.

Daughters of the King Ms. Judy Frantz, President of the DOK, Diocese of Iowa

The Order of the Daughters of the King is an order for women who are communicants of the Episcopal Church, Churches in communion with it, or churches in the historic Episcopate but not in communion with it. Our membership currently includes Anglican, Episcopal, Lutheran (ELCA), and Roman Catholic women.

In lowa, we have Daughters in 3 Chapters, in lowa City (Trinity Church), Cedar Rapids (Grace and Christ Churches) and Ames (St John's by the Campus). We also have 5 Daughters at Large, these women are not associated with a certain chapter, however, may attend.

The Mission of our Order is the extension of Christ's Kingdom through Prayer, Service and Evangelism. We have been actively praying during this Covid pandemic. Our Daily prayers include praying for the Bishop, and all priests in our Diocese, as well as for the Order of the Daughters of the King. Our women serve actively in the churches and community.

We meet via ZOOM for our Diocese meetings and Quiet Day services. We are now trying to again meet face to face with our Chapter meetings. This year a few of the Daughters have been actively involved in Conversations with Daughters via ZOOM at least once a month to discussion concerns, Healing Prayers etc. We are anxious to attend our first face to face Provience VI meeting since Covid. It will be in Nebraska this August.

Our Officers are Judy Frantz, President. Mary Westcott, Secretary. Teresa Barnett is our Treasurer. Beth Stence has volunteered to be our next President and Janet Leary has volunteered to be our Secretary. They were unanimously were voted in. They will follow Judy and Mary as they learn their duties and be installed soon. Mary Westcott is also the Province VI President for the next three years.

We tried to increase our membership by contacting the Priest at churches who do not have a chapter presently, however we did not hear back from any of the Priests. Disaster Preparedness & Response The Rev. Holly Scherff

Episcopal Relief and Development has been very busy this year.

Supporting the Episcopal Diocese of Hawai'i After Wildfires

Episcopal Relief & Development is in frequent communication with the Episcopal Diocese of Hawai'i, providing needs assessment support and other assistance on Maui and other islands in response to the recent deadly wildfires.

The Diocese of Hawai'i has been working with the local government, faith groups and local nonprofits including A Cup of Cold Water to feed displaced people, provide medical and pastoral care and give support as people fill out forms for assistance.

A Cup of Cold Water, a ministry formed by several Episcopal churches on Hawai'i, is a van ministry that serves unhoused people and other people affected by poverty. The ministry provides food, clothing and hygiene products throughout the island.

In solidarity with the local government and people, Episcopal Relief & Development is strongly encouraging people who live in the continental United States to not travel to Hawai'i or send in-kind donations at this time. Instead, please pray with the people of Hawai'i as they grieve and consider making a donation to the Hawai'i Emergency Response Fund that will support the wildfires response work.

Episcopal Relief & Development is supporting partners in seven countries

Following cyclones and heavy rain in Africa, Asia, South America and Oceania, and in coordination with nine local partners, Episcopal Relief & Development will reach over 12,000 people and an additional 6,000 households.

The U.S. continues to see and feel the effects of global warming in 2023.

Fires and flooding have ravaged North America and we are heading into what could be one of the worst hurricane seasons on record. Covid and its financial hardships continue to linger. Division and hatred for our neighbors continues to fuel the endless mass shootings that happen daily in our country.

These disasters grow in intensity every year as we continue to neglect our duty of being good stewards of God's creation, and the forecast for the next several decades is heart wrenching.

As Bishop Monnot said, "We are in unprecedented times." As we look to the future at increasing devastation due to climate change, and the total disregard for human life, we must prepare ourselves and our communities. Do you have the tools you need to prepare yourselves? What will you do when (not if) a disaster strikes your community?

Our friends and partners at Episcopal Relief and Development have posed the question that we all need to consider. "What if we thought about disaster planning as connecting with God? Just as God remembers those who mourn, are brokenhearted and disenfranchised, we can too. Let us be intentional in remembering those who are most in need in our communities, especially during disasters and extreme weather. After all, God is in the details."

Episcopal Diocesan Ecumenical and Interreligious Officer The Rev. Jean McCarthy

EDEIO (Episcopal Diocesan Ecumenical and Interreligious Officers) was able to hold their annual gathering at the National Workshop of Christian Unity this year in Milwaukee, WI, on May 8-11,2023. The work of ecumenism and our various ongoing dialogues continue.

The dialogue with the United Methodist Church working toward full communion continues, but is "on hold" in this painful time in the UMC. They are asking what is means to be church – what it means to be United Methodist -- and how to move forward in a time of disagreement. EDEIO continues to meet and dialogue with UMEIT, the United Methodist Ecumenical Officers. We remain in prayer together.

We also meet regularly with the Lutheran ecumenists (LERN) and the Presbyterian Ecumenists. The National workshop on Christian Unity continues to expand its membership and expand the opportunities to dialogue with others.

The Week of Prayer for Christian Unity falls between the Feasts of Peter and Paul, January 18-25. The theme this year was prepared by an ecumenical team from Burkina Faso: "You Shall Love the Lord your God. . .and your Neighbor as Yourself. . ." Materials are available now on the World Council of Churches Website: https://www.oikoumene.org/resources/documents/resources-for-the-week-of-prayer-for-christian-unity-2024.

The study together this year was "The Way of Jesus is the Way of Justice" by Stephanie Spellers, who serves as Presiding Bishop Michael Curry's Canon for Evangelism, Reconciliation, and Creation. She is the author of *The Church Cracked Open*. She quoted Presiding Bishop Michael Curry: "We belong together. We need all the traditions and perspectives to hear all the gospel." We do not need to agree on everything, but we do need to always seek justice and do good. Justice is the heart of God: God in action; God working through us." The world needs to hear this and begin to embrace the "gift of diversity" in the midst of the divisions and pain we experience today. Through the four days together under the leadership of Stephanie, she expanded on this focus, and led us in dialogue and conversation.

Serving the Diocese of Iowa as the Ecumenical and Interreligious Officer these past 20 years has shaped much of my service as a priest in Christ's Church. We are finding new ways to communicate in the wake of the disruption of "the way we have always done things" and added new forms of communication through dialogue through Zoom between our annual gathering at the National Workshop on Christian Unity. May we continue to enrich each other and learn from each other in doing God's work in our world today.

GILEAD Grants

Ms. Traci Ruhland Petty, Missioner for Communications and GILEAD

2023 is the fourth year GILEAD Grants were available. Applications received spanned four grant categories and proposed some amazing and innovative ideas for serving each other, our congregations, and our communities. The GILEAD Grant Review Committee is made up of individuals from across the diocese representing various churches, ministry areas, and areas of expertise. After the 2022 grant cycle the three-year term of serving on the Committee ended for those original members; a new Committee was formed which includes 4 members from the original committee and 4 new members, all of whom now serve together for a two-year term. The Committee meets with applicants and helps them strengthen their project idea ahead of application submission, reviews the grants, and proposes their recommendations for funding to the Board of Directors. At the time of writing this report, the Board has not yet met to consider the 2023 grant cycle – they make the final decision on grant funding. 2023 grant awardees will be announced at convention.

Since the last Convention, GILEAD Grants for the 2022 cycle were awarded. In the 2022 GILEAD Grant cycle, the following 10 applications were approved for funding, totaling \$79,000 in grants awarded in these categories:

LatinX Ministry in Iowa The Rev. Sherri Hughes-Empke

My regret for this past year is that recently we dropped the weekly zoom services for the women at Mitchellville. The minister with whom I was working was asked to come back for weekly in person services. However, they declined to allow him to continue to invite me to the services that were being held in person. I am grateful for the time I spent in 2022 doing this weekly ministry. I am praying for a "change of heart" within the Mitchellville management and Minister Paul is also advocating for a return to ministry for the Spanish speaking women.

I spoke with Stacey about perhaps trying to reconnect with Amilcar who asked her about me several weeks ago. I have left phone messages for him but we have not reconnected. He has been consistent about his desire for Eucharist in Spanish. We were never able to establish a "group" time and place but I have found that working with individual families who are interested in having Eucharist in their homes has been more successful than trying to "organize group worship". Let us pray that this may happen!

Just this past weekend, I met a family in Denison whom Diana Wright had wanted me to visit. There may be a possibility of having Eucharist in Spanish with this family.

I continue to celebrate Eucharist in the homes of families in Muscatine and Des Moines.

I was called upon to help one of the Des Moines families "heal" after the parents decided that they needed to divorce. I have been working on baptismal preparation with the children in this family. (Their mother told me recently that they were not baptized in San Salvador before they escaped.)

We continue to have weekly centering prayer services and Bible Services with a group at Trinity Methodist here in Des Moines. We generally have good groups in the fall, winter and spring. Over the summer we had fewer attendees.

I am grateful for the opportunity to serve this population. I would appreciate "referrals" if any priests/deacons know of Spanish speaking families who might benefit from a periodic Eucharist or pastoral visits in their own language!

Safe Church, Safe Communities Training Ms. Amy Mellies, Diocesan Coordinator

Safe Church, Safe Communities training was released in the fall of 2021. This new training platform was put together in part with Praesidium Academy and the Safe Church Task Force, a part of The Episcopal Church. The Safe Church Task Force has released eight of nine courses. The Diocese of Iowa released a training chart in the spring of 2022 and it is available on our website.

Online training is available through the administrator in your congregation who will set up individuals in the system for online training. In person training can be done in a group setting via the online courses. Safe Church, Safe Communities training will need to be completed every three years.

In 2023 a Safe Church Advisory team was put together under the advisement of Bishop Monnot. Team members are: Rev. Nora Boerner, Rev. Kyle Carswell, Ven. Judith Crossett, Rev. Brian Gross, and the chancellor, William Graham. The team was created to advise on questions from congregations, encourage members of the church to take part in the training, and to become in-person trainers. Three members of the group have received training and in-person training will be offered in 2024.

Diocesan Lifelong Christian Formation

Education for Ministry The Rev. John Doherty, EfM Coordinator

This is the 37th year for Education for Ministry (EfM) in this Diocese and the 50th anniversary of EfM. The Diocese of Iowa is a supporting diocese which provides coordinator training and financial discounts for people registering. For the 2022-23 year there were 29 active students in four groups: Ames (St. John's), Cedar Falls (St. Luke's), Des Moines (St. Paul's), and Iowa City (Trinity). The Diocese has 4 active administrator mentors and several co-mentors. The curriculum helps develop an individual's

spirituality and encourages mutual ministry. It also fosters evangelism in that it prepares individuals with the academic and theological background go out into the world and be witnesses to their faith. In person training has suspended for 2020-2022 in Iowa. Some of our groups continue to meet online while others are returning to in person with Zoom options. Anyone seeking more information about becoming a mentor or joining a group should contact me. The online groups are open to people regardless of their location and is a wonderful opportunity for those who do not have a group at their church. Central Chapter Ms. Rita Baker

The Central Chapter of the Episcopal Diocese of Iowa is comprised of three congregations: St. Paul's Marshalltown, St. Paul's Grinnell and St. Stephen's Newton. Chapter meetings have been held on ZOOM, exclusively. There have been no in-person meetings or shared events.

- **St. Paul's Marshalltown** is benefitting from the use/rental of their great hall. One half is used for the free store to meet community needs. The second half is rented to the Community Theater for auditions and practices. They placed an ad in the local newspaper inviting people to church with no expectations and it has garnered a few takers. Their food box continues to be well-received. They have enjoyed an abundance of flowers on the grounds this summer. Services and studies remain about the same.
- **St. Paul's Grinnell** is enjoying increased membership in the fall with the return of college students. They have raised about \$4,000.00 for humanitarian relief for Ukraine. They partner with several groups including the Grinnell Ministerial Association, MICA, Second Miles, AA, Al Anon, and Poweshiek County Public Health. They also share space for rehearsal of the Bagpipe Band. They are planning the addition of a deck and memorial garden in the back yard of the church, which will provide space for access and fellowship. Services and studies remain about the same.
- **St. Stephen's Newton** has enjoyed attendance at their on-line services. Although in-person has resumed, the services and studies are still offered on-line. They are still preparing monthly casseroles for Capstone Behavioral Healthcare's "Connections," a peer drop in center. Their Blessing Box is across the street from the church on Connections' property and is stocked year round. They conducted a matching fund drive to help pay for student breakfast and lunch accounts that are in arrears which raised \$1,000.00. They partner with as many as 15 12-step groups which meet in the church. They also partner with the Salvation Army, eight downtown churches for public ecumenical events, neighbors Helping Neighbors for clothing and laundry assistance, Jasper County Cares Coalition of human service providers, and Jasper County Public Health. St. Stephen's is looking forward to the celebration of their 150 th Anniversary in 2024.

Members of the Central Chapter are anticipating the addition of in-person meetings along with the Diocesan ZOOM meetings in 2024.

East Chapter The Rev. Elaine Caldbeck, Convener

At both the Spring and Fall Chapter meetings at least eight churches participated, and enjoyed our interactions. (Especially the two Fr Kevin's).

Each congregation works with neighboring churches and organizations, such as ministerial associations, to serve our communities. Dubuque has done outstanding work with the grant that allowed them to do billboards and events to support a NICE campaign, as well as seminarian interns from local seminaries.

Most congregations are involved in feeding programs or food pantries. Some, Bettendorf, Maquoketa, and Trinity Davenport especially mentioned hosting concerts. Others have shared Vacation Bible School with neighbors as well. Links have been made with Lutheran and Methodist neighbors. A few are in search for clergy leadership, Trinity Davenport, and Clinton.

Most report participating in organizing and giving schools supplies, Thanksgiving and Christmas food and gifts. Some spoke of member formation plans and activities. The three quad cities parishes will be having a picnic together and look forward to building and renewing friendships.

Other exciting news is a big turnout in Muscatine for blessing of Backpacks, a bumper crop of children in acolyte training at Trinity Davenport. Dubuque, Muscatine, and Trinity Davenport have numerous programs they participate in locally to serve their communities.

All in all, while we may differ and view diocesan budget plans through different lenses, we appreciate one another and do what we can to support our communities.

Metro Chapter Report Mr. Morrie Bryant, Chapter Board Representative

The Metro Chapter met, via Zoom, during both joint chapter meetings held April 1st and August 26th. In both meetings we had six parishes participating:

St. Timothy's - WDSM, Grace Church - Boone/Webster City, St. Paul's Cathedral - DSM, St. Anne's - Ankeny, St. John's - Ames, and St. Andrew's - DSM.

- Metro Episcopal Youth and Family Gathering serving the Faith and Grace Garden hosted by St. Timothy's.
- Bishop Ezekiel Ajaang visit hosted by Trinity Cush.
- Youth choir, community conversations, Connections Cafe with a new social work component St. Paul's Cathedral
- LGBT youth group for a monthly safe place to gather Grace Church
- Young Adult Pilgrimage
- Nicola's installation as Dean of St. Paul's Cathedral!
- Ordination of Catherine Schroeder and her efforts to support smaller congregations
- Book Studies! Grace Church
- Teaming up to reach out and connect to ISU students St. Timothy's and St. John's
- Expanding the neighborhood garden and Blessing Box St. Anne's
- All Metro parishes sharing their Holy Week services and activities with each other!

Challenges:

- Worshiping on-line ... how do we better connect with on-line participation?
- Attracting and maintaining young adults and families.
- Reaching out to people in need, especially those who feel they are "just done" with church.
- Building an operational budget for the parish with income declining.
- Managing an aging congregation and dealing with the fact that younger members cannot or do not fill the stewardship gap left by retirees who move away.

2024 Diocesan Budget Discussion (8/26/23 meeting)

- Very positive feedback from Metro Chapter regarding presentation ... really liked the transparency ... "more democratic" approach than in the past.
- Really liked the polling ... offered good immediate feedback.
- Metro Chapter reached consensus that 1. Cutting the 2024 budget was NOT the way to go;
 Investing in ourselves now IS the way to proceed, 3. BUT, we will have to change and structure things differently, and 4. we will need a timeline because Opportunity Funds and borrowing from our investments is not sustainable long term.

Metro Chapter Report Summary

The chapter has a spirit and desire to work together. We look forward to having all of our parish members join us. We recognize that we, together, along with all of the other churches in lowa, are the diocese. This sense of unity and commitment to ministry offers a strong foundation from which to move forward. The chapter appreciated being involved in the budget conversation on August 26th, and also wants to learn more about church finances and operations. Specific questions regarding church assets and how they are defined offer an excellent educational opportunity. The chapter also wants to learn more about ministries such as Indian Mission, Old Brick, and Way Station.

Southeast Chapter The Rev. Carl Mann, Clerk pro tem

Although there are 4 churches in the Southeast chapter, in 2023 only 3 churches at a time were represented in our chapter's breakout sessions of the Spring and Fall Joint Chapter meetings. Time together in our breakout room was spent checking in with each other using the questions suggested in the joint meeting. Since the last Convention, we have not gathered beyond the Joint Chapter meetings due to busy schedules, health issues, and survival.

Southwest Chapter Ms. Karen McCallan, Convener

The chapter met in breakout session after the spring joint session on April 1. Representatives present were from St. Martin's, Perry, St. John's, Glenwood, St. John's, Shenandoah, and Trinity Cluster (Rev. Diana representing the 3 churches). The chapter nominated R. J. Fitzgerald to be the lay rep for the Board of Directors. (This was done at a special meeting via on May 20).

Discussions were prompted by the questions that were presented at the joint meeting. St. John's. Glenwood continues to support work of the local ministerial association, participate in ecumenical services and fund raisers. They share the cost of church calendars and palms. The treasurers exchange their finance records for review as required by the diocese. St. John's, Shenandoah participated in an ecumenical soup supper fund raiser for Heifer International. Rev. Holly serves as pulpit supply for the UCC church in Red Oak and has been asked to be their pastor. Trinity cluster: Rev Diana will be starting her 11 th year of service to the cluster. Brother Dowd presented his program on Contemplative Prayer at the church in Denison, Harlan is planning on building a gazebo with hopes of offering gatherings in it once a month. The church was used for a meeting regarding Human Trafficking. The church is also the cooperate headquarters for a car detailing company. St. Martin's in Perry is very active with the local ministerial association, ecumenical services, meals and fund raisers. They have worked with the Lutheran church in a program that provides bedding for people new to the community and a program that provides rocking chairs for new moms. They are participating in the Genesis II program.

The chapter met again in the fall (Aug. 26) via zoom and in the breakout session. Churches having representation were St. John's, Glenwood, St. John's, Shenandoah, and Trinity Cluster (again Rev. Diana representing the 3 churches). St. John's Glenwood continues to provide services for Linnwood, 5 members took part in a pilgrimage of the Underground Railroad in Southwest lowa, concern for the praying hands sculpture due to bug infestations and the need to remount it on a newer foundation. St. John's, Shenandoah will be gathering in September with present and past members to discuss their future. Denison church owners are offering the use of the building to the community for meeting space, currently a group meeting there regarding anti-human trafficking, currently hosting a conference on climate change this fall. Harlan still hoping to build the gazebo and get the wiring updated. St. Martin's Perry church will be joining Webster city, and Boone at the ledges for worship and meal time. They continue to participate in Genesis II.

Some attended the Rural Shrink Smart Initiative. They are doing well spiritually and okay financially. Further discussion centered on the 3 questions regarding the budget. Our concerns were submitted in a report to the budget committee: why are they sitting on so much money in the investments? How much money is enough to provide a safety net? What is the Diocese doing with closed churches? i.e. Red Oak? If a church has an endowment, how do they go about donating the interest they earn to the Diocese?

Three Rivers Chapter Ms. Paula Sanchini, Chapter Board Representative

The Three River Chapter met via Zoom following both the Spring and Fall Joint Chapter meetings led by the Diocese in 2023. Members of Christ, Grace, New Song and Trinity churches were present at both meetings and shared updates from their parishes. Each church reported that regathering of

members is still underway and that new members are arriving as well. There's a sense of optimism and joy in our congregations.

Trinity-lowa City has been in transition this year as they seek a new rector. Rev. Jim Harrison accepted the position of Interim Rector on September 1. Trinity called Rev. Nora Boerner as Associate Rector as well. Rev. Boerner is serving as Interim Community Missioner at the Beloved Community Initiative for the Episcopal Diocese of Iowa this year. Trinity launched a young adult ministry and Episcopal campus ministry at the University of Iowa this fall. The group shares a community meal followed by contemplative worship each week.

Timely installation of air conditioning in the Medical Lending Closet **at Grace-Cedar Rapids** just ahead of the recent record-breaking heat was celebrated by both volunteers and those seeking medical equipment. Grace has introduced new liturgical practices while welcoming new members this summer.

New at **Christ Church-Cedar Rapids** starting in October, Christ Church will offer a Celtic Service on Sunday evenings. The service will feature worship in the Celtic tradition and live music offered by local musicians. A new ministry has formed around addressing mental health needs of our communities by providing access to training for church leaders who wish to be better informed. They are planning a workshop for next spring. In September, Christ Church will offer a special liturgy geared toward suicide prevention.

Renewed energy and a passion for ministry and outreach are tangible at **New Song-Coralville**. The reentry mission of the church continues as New Song looks forward to sharing a meal with participants in the Inside Out ministry in September. They made a deliberate effort to support refugees and immigrants in the Coralville area this year and polled those present at the chapter meeting about similar efforts in their communities.

As a result of major repairs at Old Brick, rents and event planning approach pre-pandemic levels. **Agape Café** continues to thrive, averaging 70 meals each week in its 30th year. With new coordinators who are passionate about feeding people in place, the café has been able to return to the original mission of offering breakfast meals made to order, while also offering take-out for a limited number of 'specials'.

The Three Rivers Chapter churches hosted a Welcome to lowa Picnic for the young adult pilgrims and their accompanying bishops from the Diocese of Brechin, Scotland, the Diocese of Swaziland, Eswatini, and the Diocese of Iowa on August 11, 2023. Grace, Trinity, New Song & Christ churches organized, set up and carried out the event with over 110 people gathering on the front lawn at Christ Church, Cedar Rapids. Featuring Rev. John Greve as grillmaster, the picnic offered pork chops, sweet corn and an abundance of Iowa picnic fare contributed potluck style. Fellowship abounded as the pilgrims were warmly welcomed, introduced themselves and engaged individually with the enthusiastic Iowa Episcopalians in attendance. Worship centered on the planting of a 'Communion Tree' and featured pilgrim voices. The Episcopal Diocese of Iowa and The Episcopal Diocese of Brechin now nurture part of the Communion Forest, a global conservation initiative launched at the Lambeth Conference in 2022.

Actions of the Chapter include:

- 1. Nomination of the Rev. Brian Gross, Priest in Charge at Christ Church, Cedar Rapids, for a three-year term as clergy representative to the Board of Directors from the Three Rivers Chapter.
- 2. Reporting out responses to diocesan requests for information.

While generally supportive of the Draft Budget, those present request more detailed information about the structure and implementation of an Opportunity Fund and use of endowment funds. There is concern about drawing on endowment to address budget shortfalls. Additional details about the elements in the plan would allow for more incisive assessment of it. A list of specific questions and concerns was sent to the Ways and Means Committee.

Province VI

Ms. Ann McLaughlin

The Province VI Council, which includes members from Colorado, Iowa, Minnesota, Montana, Nebraska, North Dakota, South Dakota, and Wyoming, has been busy this year.

We have started a Small Church discussion group that meets over Zoom and open to all who are interested from the province. This group started because of the wonderful participation that we have in the lowa Small Church group that meets every week.

The Province has also retooled our grant process. Groups within our province area can apply for grants and at least three of the eight dioceses in the province must be included in the planning and implementation of the program. Applications can be requested from the diocesan office or Ellen Bruckner.

The Council also adjusted our canons to bring on one other person from each diocese. As of now, each diocese is represented by one clergy and one lay representative. Each has a three year term, which are staggered on non-General Convention years.

Finally, we continue to make plans for an online Synod in 2024 and hopefully an in-person gathering for all province members in the next couple of years.

VOTING and PROCEDURES FOR 171st ANNUAL CONVENTION OF THE DIOCESE OF IOWA

All voting on Saturday, October 21, 2023 will be done electronically. Delegates must be physically present to vote. Paper ballots will not be used. At registration, Certified Delegates will receive instructions on how to use their own electronic device to connect to the Elections software and vote. Voting will use the Single Transferable Voting system (by orders as necessary) unless a voice or raising of ballot cards vote (especially on motions) is called for.

THE RULES OF ORDER for Diocesan Convention

as proposed for the 171st Annual Convention in 2023

- The Rules of Order of the Convention are in force until the following Convention where they can
 be amended or repealed by Convention itself. Any revision or waiver of a Rule of Order shall be
 by two- thirds vote of Convention. All questions of order not resolved by reference to the
 Canons, the Constitution, or these Rules of Order shall be decided under Robert's Rules of
 Order, 12th edition.
- 2. General decorum: Once the meeting is gaveled open, please give the President of Convention your undivided attention for the duration of the meeting. Movement and talking amongst your tablemates should be kept to a minimum. The President of Convention will preside over the meeting and decide questions of order for the meeting.

Organization of business at Diocesan Convention

- 3. The business of Convention will include:
 - a. Determination if a quorum exists to conduct convention business and elections (a list of voting lay and clergy delegates will be available in the minutes of the current meeting)
 - b. Approval of the agenda for Convention, as presented by Dispatch of Business, and the Rules of Order
 - c. Acceptance of the minutes of the previous meeting and the reports to convention
 - d. Appointing the Officers of Convention
 - e. Electing representatives to serve on: Standing Committee of the Diocese, Board of Directors of the Episcopal Corporation, Disciplinary Board, Deputies and alternates to represent Iowa at General Convention and/or Province 6 meetings
 - f. Voting on Resolutions, both those proposed from around the state and those commended to us from the General Convention
 - g. The Bishop's Address
 - h. Affirming Memorial Resolutions for Clergy and other Church leaders who have died in the past year.
 - i. Welcoming new clergy to the Diocese

Resolutions

- 4. Resolutions are submitted at least 40 days before convention to the convention's Resolutions Committee in writing and signed by the person(s) who propose it. The Resolutions Committee checks to see if:
 - a. The resolution is unambiguous.
 - b. The resolution should be divided into separate propositions.
 - c. The resolution's format fits the established format for a resolution.
 - d. The resolution will be part of the Consent Calendar or the Debate Calendar.
 - e. Does not impose financial responsibility on the diocese without including provisions for funding the same.
- 5. Resolutions are given a number and provided to delegates 30 days before the convention so they can be discussed in churches and delegates are aware of the opinions of the congregation they represent. A resolution that is not published 30 days before convention may be presented in writing to the Secretary of Convention and be brought to the floor for discussion and vote provided that:

- a. They shall have been received on the Friday of the week preceding the week of Convention. (8 days ahead of time)
- b. A majority vote in favor of consideration is achieved during the first presentation of the Resolutions Committee. With the exception of procedural and courtesy resolutions, late resolutions made during the convention itself may only be considered on a vote of two-thirds majority
- c. Courtesy Resolutions and Memorial Resolutions honor or thank individuals who have served the Diocese in some special way and are not bound by the deadlines that pertain to resolutions that will appear on the Consent or Debate calendars
- 6. A motion to bring each Resolution to the floor is brought to the Bishop (as president of the Convention) by the chair of the Resolutions committee and seconded by another delegate.
- 7. An item on the Consent Calendar may be moved to the Debate calendar with a vote of 10 ormore delegates or by action of the President of Convention.
- 8. The entire Debate Calendar of Resolutions will be addressed by the convention at the meeting unless postponed by a majority vote.

While a resolution is under consideration:

- The President recognizes those who proposed the Resolution for an opportunity to explain its purpose. If the Resolution is on the Consent calendar it will get an up or down vote without debate.
- 10. If the resolution is on the Debate calendar, The President will recognize others who may want to speak in support or opposition to the resolution.
- 11. Only certified Clergy and Lay Delegates or those granted "seat and voice" may be recognized by the
 - President to speak to the convention.
- 12. When any member speaks to convention, they shall address themself to the President, state their name and church, and confine themself to the point in debate.
- 13. Debate is limited to 2 minutes per person, each person may speak for a second time to the same motion after all others who wish to speak. Convention may approve more time for debate, or more time for an individual to speak, by a majority vote.
- 14. Debate should be polite and sensitive to those on either side of any issue.
- 15. The President may, having left the chair, enter into the debate on any question, but shall not then resume the chair until the main motion under consideration has been disposed of.
- 16. The following actions are appropriate when a resolution or motion is under consideration:
 - a. Amend the Resolution: Motions to amend, motions to amend the amendment, or

motions to substitute can be passed. An amendment can have a motion carried to "Lay it on the table" as well, and then the resolution is voted on as if the amendment had never existed. Amendments may be withdrawn by the person who moved it, with the consent of the person who seconded it, before the resolution is put to a vote. Amendments must pertain to the subject of the resolution.

- b. **Limit or end debate** ("previous question" or "calling the question") by a two-thirds majority vote.
- c. **Move consideration** of the resolution to a future time ("time certain") by a majority vote (later in the same Convention).
- d. **Refer** the resolution to someone other than the convention itself by a majority vote:
 - i. Standing Committee, Board of Directors or any other permanent commission or committee of the Diocese;
 - ii. Any permanent committee of convention (such as resolutions, etc.); or,
 - iii. Any ad hoc committee appointed by the Presiding Officer
- e. **Postpone indefinitely** by a majority vote (effectively ends consideration of the motion).
- f. "Lay on the Table," which postpones the resolution or motion until and unless it is taken up again) "taken from the table") later in the Convention.
- g. Vote on it
 - i. The President will announce the method of voting appropriate for the matter at hand and the threshold it needs to pass. Voting may be by simple voice vote, by holding up different colored cards, or by other means.
 - ii. A simple majority is sufficient for passing most resolutions with these exceptions:
 - a. Some votes may be "by Orders" where required by the Constitution or Canons. A vote by orders means that the Lay Delegates vote separately from the Clergy Delegates and a majority in both orders is required.
 - b. Some matters require a two-thirds majority, when required by the Constitution or Canons.
 - iii. The President, or any member of Convention, may ask that a voice vote be confirmed through a roll call or a count of voting cards ("division").
 - iv. All votes are final and won't be revisited UNLESS On the same day the vote is taken, a delegate who voted in the majority may make a motion to "reconsider" and that must be seconded by another delegate who voted in the majority. (or at least 3 delegates from the majority side and in each order in the case of a vote by orders). When that happens, the resolution may be resubmitted to be considered.
 - v. In the case of a conflict of interest, it is appropriate for that delegate to not vote on that question.
 - vi. The President may also recess convention, but may be overturned by a two-thirds vote by both orders, especially if a recess may be for getting pertinent information for making informed decisions.

Who is certified to vote?

17. Lay Delegates: Each congregation's vestry elects Lay Delegates (no less than 2 and rising in

number based on the congregation's number of communicants) at the first vestry meeting after the congregation's annual meeting. Those people who were elected to represent their church must be present at the convention to vote.

- 18. **Clergy Delegates:** All canonically resident clergy attending convention may vote. Additionally, Evangelical Lutheran Church of America clergy who are serving a congregation in this Diocese, with the permission of the Bishop, shall have a seat, voice, and vote in convention.
- 19. In addition, any lay member of the Standing Committee who is not otherwise elected as a congregational delegate to Convention, the Archdeacon, the Executive Secretary, the Chancellor, the Convention Secretary, the Treasurer, the Historiographer, and the Registrar of the Diocese, each shall be entitled, ex officio, to a seat, voice, and vote in the Convention.

Elections

- 20. The Nominations Committee solicits and receives nominations from individuals, churches, committees and chapters for the brightest and the best to serve from all over lowa. Nomination deadlines:
 - a. Nominations close 120 days before convention.
 - b. Biographical information is made public for consideration by delegates 30 days before convention.
 - c. Nominations will be accepted from the floor of convention only if the person nominated has agreed to fill an office if elected.
- 21. When the President announces that election voting has begun:
 - a. Ballots are cast electronically (or may also be on paper) using the Single Transferable Voting system which requires all delegates to rate their preferences by number on the ballot.
 - b. Ballots are cast on the first day of Convention and Results are given to the President of Convention and announced during the last plenary session of convention.
 - c. Elections for the Standing Committee, Board of Directors, General Convention Deputies, and any other body so directed by the Constitution, Canons, or By-laws are elected by orders, using the Single Transferable Voting system.
